The Federal Supreme Court (F S C) has been convened on 2/6/2024 headed by Judge Jassim Mohammed Abood and membership of Judges Sameer Abbas Mohammed, Ghaleb Amir Shunain, Hayder Ali Noori, Khalaf Ahmed Rajab, Ayoob Abbas Salih, Dyar Mohammed Ali Munther Ibrahim Husain, and Jassim Jazaa Jaafr who are authorized in the name of the people to judge and they made the following decision:

The Plaintiffs: Talib Abdel Moneim Najem, Watheq Ghadban Khudair, Ali Husain Yahya, Ali Abdulkarim Sarhan and Saif Ali Abd Al-Kazem, Thuraya Khalaf Abdul Abbas and Zahraa Ziad Atshan.

The Defendants:

- 1. Speaker of the Council of Representatives / being in this capacity His two agents the human rights employees Saman Mohsen Ibrahim and Aseel Samir Rahman.
- 2. Parliamentary Health and Environment Committee.

The Decision:

Upon scrutiny and deliberation by the Federal Supreme Court, it was found that the plaintiffs filed their lawsuit before this court and requested a ruling to do justice to the segment of radiation workers in health institutions in Iraq, due to the failure to stipulate that they are covered by the provisions of Law No. (1) of 2024 (the National Authority for Nuclear, Radiation, Chemical and Biological Regulatory Law), and after registering the lawsuit and collecting the legal fee for it, and informing the defendants of its petition and documents in accordance with Article (21/1st and 2nd) of the court's internal regulations. No. (1) of 2022 the first defendant's agents responded to the reply statement dated 12/5/2024 and requested to reject the lawsuit for

the reasons stated therein, and after completing the procedures in accordance with the requirements of the court's internal regulations, a date was set for considering the case without pleading in accordance with Article (21/3rd) thereof, in it, the court was formed and examined the plaintiffs' requests, their supports, and the defenses of the defendant's agents, and noted that the plaintiffs submitted the request dated 22/5/2024 requesting the annulment of the lawsuit petition, and for the approval of the request to the law and based on the provisions of Article (88) of the Civil Procedures Law No. (83) of 1969, as amended, the court decided to annul the plaintiffs' lawsuit petition (Talib Abdel Moneim Najem, Watheq Ghadban Khudair, Ali Husain Yahya, Ali Abdul Karim Sarhan, Saif Ali Abdel Kazem, Thuraya Khalaf Abdel Abbas and Zahraa Ziad Atshan) and charge them the full advocacy fees. The defendant's agent received an amount of one hundred thousand dinars, and the decision has been issued unanimously, final and binding in accordance with Article (94) of the Constitution of the Republic of Iraq for the year 2005 and it has been edited in the session dated 23/Dhu al-Qa'dah/1445 A.H. corresponding to 2/6/2024 AD.
