The Federal Supreme Court (F S C) has been convened on 30/7/2024 headed by Judge Jassim Mohammed Abood and membership of Judges Sameer Abbas Mohammed, Ghaleb Amir Shunain, Hayder Jaber Abid, Hayder Ali Noori, Khalaf Ahmed Rajab, Ayoob Abbas Salih, Dyar Mohammed Ali, and Khalid Taha Ahmed who are authorized in the name of the people to judge and they made the following decision:

The Plaintiff: Ahmed Abdul Allah Mohamed Al-Jubouri / Member of the Council of Representatives- His agent the barrister Haider Saeed Musa.

The Defendants: 1. Speaker of the Council of Representatives, being in this capacity - His two agents the human rights employees Saman Mohsen Ibrahim and Aseel Samir Rahman.

2. Mohsen Ali Akbar Al-Mandalawi / First Deputy of the Speaker of the Council of Representatives.

## **The Decision:**

Upon scrutiny and deliberation by the Federal Supreme Court, it was found that the plaintiff (Ahmed Abdul Allah Mohamed Al-Jubouri / member of the Council of Representatives) filed his lawsuit before this court, quarreling with the two defendants (the Speaker of the Council of Representatives / being in this capacity and Mohsen Ali Akbar Al-Mandalawi / First Deputy Speaker of the Council of Representatives) and requesting a ruling on the invalidity of the negative decision of the Council of Representatives represented in refraining from deciding on the validity of the membership of the representative (Mohsen Ali Akbar Al-Mandalawi) and reversing it, and ruling to terminate the membership of the said representative, for the reasons stated in the lawsuit petition.After registering with this the lawsuit court No.
